Section 4: First aid measures

4.1 Description of first aid measures

Skin contact: wash the contaminated skin with plenty of water. Consult a doctor if disturbing symptoms appear.

Eye contact: wash the contaminated eye with plenty of water for 10-15 minutes. Keep eyelids wide open. Avoid strong stream of water – risk of damage of the cornea. Consult an ophthalmologist immediately.

Ingestion: rinse mouth with water. Never give anything by mouth to an unconscious person. Consult a doctor immediately, show the container or label.

Inhalation: remove the victim to fresh air. Keep victim warm and calm. Consult a doctor if disturbing symptoms appear.

4.2 Most important symptoms and effects, both acute and delayed

Skin contact: redness, burning sensation.

Eye contact: tearing, burning sensation, irritation.

Ingestion: possible stomach ache, nausea, vomiting, diarrhea, irritation of throat and esophagus.

Inhalation: exposure to high concentrations of product vapours may lead to headaches, nausea.

4.3 Indication of any immediate medical attention and special treatment needed

Section 5: Firefighting measures

5.1 Extinguishing media

Suitable extinguishing media: adapt the extinguishing media to surrounding materials.

Unsuitable extinguishing media: water jet – risk of the propagation of the flame.

5.2 Special hazards arising from the substance or mixture

During the fire, the product may produce harmful gases of carbon oxides, sulfur oxides and other hazardous, unidentified products of thermal decomposition. Do not inhale combustion products, they can be dangerous for human health.

5.3 Advice for firefighters

Limit the access for the outsiders into the breakdown area, until the suitable cleaning operations are completed. In case of a large release, isolate the exposed area.
